We use cookies and similar technology for the collection, use and/or disclosure of data as part of our business operation as described under this cookie policy of the Company ("**Cookie Policy**"), which shall be applicable to websites, mobile applications, social networking sites, online communication channels, and other means that we use for the collection of your personal data.

1. WHAT ARE COOKIES AND WHY THE COMPANY USES COOKIES

Cookies are small pieces of data or text which are placed on your computer when you are browsing a website, and used for collecting and tracking your activity on website, analyzing trends for the purpose of our website administration, tracking user's browsing activity, or saving user's setting. Some of the cookies are essential since they help maintaining normal function of the website. Cookies could safely remember your username and language setting as well.

2. WHICH TYPE OF COOKIES THE COMPANY IS USING

We use our cookies and third parties' cookies for different purposes as follows:

Strictly Necessary Cookies	These cookies are necessary for you to browse and use several features on our website, such as accessing safe space on our website. We use strictly necessary cookies to ensure that our digital services provide its basic functions correctly and perfectly.
Performance Cookies	We use performance cookies to calculate frequency and pattern of your site visits, such as your most visited page. We use this data to improve website efficiency and user experience.
Functionality cookies	These cookies help website to remember you and your selections (e.g., selected language, or region) so that better and proper

	experience could be served to you. In addition, these cookies are also able to remember changes of text size, font, and other parts of the webpage per your own preference.
Advertising cookies	These cookies are used to display ads based on relevant topics that interest you. Moreover, they are used to limit number of ads seen, measure performance of our advertising campaigns. Sometimes, we share de-identified data regarding your visiting to our advertising and creative alliances. These alliances may use the data to display ads that may interest you on other sites and develop our advertising campaigns in the future.
Security cookies	We use security cookies for you to have faster and safer interaction with us. These cookies identify and prevent possible security risks.
Third-party cookies	<p>Please be informed that third parties may use cookies via our website to display relevant ads that interest you according to your browsing activity.
